If a candidate remains absent during scrutiny as per schedule or any discrepancy of fact is found at any stage, his/her candidature will be cancelled and no further communication will be entertained.

Merit position will be prepared as per weightage pattern mentioned in the notification dt. 21.02.2026. Weightage will be calculated by the Board after scrutinizing all the documents as will be received from candidates during scrutiny of documents. After calculating weightage recommendation for recruitment will be made as per merit and as per vacancy position as mentioned in the above notification dt. 21.02.2026.

Candidates are instructed to remain present on the scheduled date of scrutiny. During scrutiny, mark sheets, certificates of academic and professional qualification including other relevant certificates / documents of candidates will be examined. Candidates are instructed to bring the following in original and 2 (two) sets of self-attested photocopies of the referred documents during scrutiny.

**(1)**Acknowledgement page of Online application for Under Graduate Teacher (UGT) / Graduate Teacher (GT) - 2026. **(2)** T-TET Certificate cum Mark-sheet. **(3)** Permanent Resident of Tripura Certificate (PRTC). **(4)**Admit Card of matriculation/madhyamik examination as age proof. **(5)**Caste certificate (if applicable). **(6)** PH Certificate (if applicable). **(7)** Mark-sheets (all semesters/years) of academic qualification. **(8)** Mark-sheet (all semesters/years) of professional (teacher training) qualification. **(9)** Certificates of academic and professional qualification (if any). **(10)** Photo bearing identity card like PAN Card, Voter ID (EPIC), Passport, AADHAR etc. (any one). **(11)** No-objection certificate from the concerned authority (for in-service candidate). **(12)** Certificate/proof of ESM (for ESM candidate).

Candidate who applied for both Under Graduate Teacher (UGT) and Graduate Teacher (GT) are instructed to bring 4 (four) sets of photocopies of required documents, 2 (two) sets for Graduate Teacher & 2 (two) sets for Under Graduate Teacher for simultaneous scrutiny. Such candidates will attend only on the date of scrutiny as scheduled for UGT and they will not be required to attend for scrutiny scheduled for GT.

**IMPORTANT NOTES:**

- A. Obtaining one's certificate scrutinized does not confer any right on any candidate for recruitment since it depends on fulfillment of conditions of eligibility and number of vacant posts (as per notification). Candidates will be recommended for recruitment as per vacancy.
- B. If a candidate doesn't turn up during scrutiny as per schedule of TRBT or any discrepancy of fact is found during scrutiny, her/his candidature will be cancelled and no further communication will be entertained.
